One-Eighty's Consignment Policy!

ITEM INTAKE IS BY APPOINTMENT ONLY, NO DROP-OFFS*

- Keep in mind that we are typically scheduling 2 -3 weeks out!
- No appointment needed to consign furniture, but you must call ahead before bringing furniture.
- Furniture drops will only be accepted before 3PM on Thurs. & Fri. Before 1PM Sat.
- All sales are 50/50 split
- You can bring up to 40 items per appointment. If you need to bring more, please let us know when you schedule so we can make arrangements.
- Bring items in boxes or bags if possible.

Item Requirements

- In Season, clean and ready to display
- Items needing cleaned will result in a 10% penalty to your account.
- Complete & working! (all parts & pieces, cords, etc.)
- Make sure you electronic / electrical items are working.
- Items are assessed at intake, any items believe to be unsellable will be returned to you immediately.
- We track your sales only! We do not inventory items. We will not be able to tell you which items have sold.

60 DAY CONSIGNMENT TERM:

- Items will be displayed for 60 days! Prices may be adjusted at any time.
- Your items will usually be displayed the same day, but may be later.
- It is your responsibility to track your item expiration dates. We are unable to tell you when an item expires.

RECLAIMING YOUR UNSOLD ITEMS (OPTIONAL):

- Any items you want to reclaim must be retrieved before their 60 day expiration date.
- Items left beyond their 60 day term become store property and are not to be removed from the store.
- We reserve the right to sell expired items, with no credit to you, or donate them, at our discretion.
- To retrieve your items you must find them in the store and bring to the front counter before removal.

CONSIGNOR PAYMENT: FIRST THURSDAY OF EACH MONTH - \$10 MINIMUM

- Consignors are paid by check only, no store credit. We cannot cash your check in store.
- Any amount under \$10 remains in your account & is rolled over from month to month until you reach \$10
- Checks not picked up within 90 days will be voided and forfeited altogether.

WHAT WE DO NOT ACCEPT:

- Dirty, stained, ripped clothing
- Movies rated over PG-13 I.E. no "R"rated / adult movies
- Mattresses, bed pillows, old baby cribs, recalled items.
- General Magazines (entertainment, Good Housekeeping, etc.)
- Old style T.V.s, and computer monitors
- Printers
- Large exercise equipment
- Items beyond resale condition (poor condition / no market value)
- Any other items we deem unsellable at our discretion.



Consignment Agreement ~ Consignor Number: _____

By signing you are agreeing to the terms found in our consignment policy (copy you receive) as well as these terms:

1. **MERCHANDISE SALE:** Consignor agrees to consign item(s) to One-Eighty Consignment & Thrift Shoppe at 10 East State Street, Albion, PA. Consignor warrants they possess complete and clear title to all merchandise consigned and will NOT hold 180 responsible for any claim from another party to consigned merchandise. If an item is found to be recalled, the consignor forfeits the item to be disposed of by 180 **without notice**.
 - a. 180 reserves the right to decline or donate items deemed unsellable (due to flaws found during the pricing process) at its own discretion.
2. **RETAINED FEES FOR MERCHANDISE:** 50% of the selling price of each item shall be retained by One Eighty Consignment & Thrift Shoppe. The remaining portion will be paid to listed consignor only. If we must clean an item, or an electric item is returned due to it not working, by a customer, the consignor percent will decrease by 10
3. **LIABILITY:** While every reasonable effort will be made by 180 to safeguard consigned merchandise, 180 assumes **NO LIABILITY** for the loss, damage to, or destruction of, any consigned merchandise by fire, theft, accident, or any other cause.
4. **PRICING:** Prices are set at the sole discretion of 180 unless otherwise agreed upon. Prices may be adjusted at any time.
5. **RECLAIMING MERCHANDISE (OPTIONAL):** Unsold items can be reclaimed before or at the end of consignment terms (60 days). IT IS THE SOLE RESPONSIBILITY OF THE CONSIGNOR TO RECLAIM THEIR ITEMS BEFORE THE 60 EXPIRATION DATE. We will NOT NOTIFY the consignor prior to expiration. Items left after the 60 day term will automatically become the property of 180.
6. **CONSIGNOR PAYMENT:** Checks are issued monthly to consignors who have at least \$10.00 in their account. Checks are available the first Thursday of the month. Consignors with less than \$10 at the end of the month, will have their balance carried over to the next month(s) until a minimum \$10 is reached or account is closed.
 - a. It is the consignors sole responsibility to pick up their check, we cannot mail checks.
 - b. Checks not picked up within 90 days will be voided and forfeited.
7. **ACCOUNT TERMINATION:** You can terminate your account at any time. 180 can terminate your account if provided an invalid address or phone number and are unable to contact consignor, and consignor will forfeit their account balance.
8. **DISPUTES:** All transactions and resolutions to disputes will take place in Erie County, PA, USA.
