ITEMS TO BE SOLD:

Please note restrictions for individual events if applicable.

SET-UP/ BREAKDOWN:

The fair will be held at One-Eighty Annex, 18 East State Street, Albion, PA from 10:00am-3:00pm. Vendor set up begins at 8.45 am. Break down can start no sooner than 4:00 pm on Saturday and must be completed by 4:30pm. No vendor is to close before the official closing time. Sellers are responsible for their selling spaces.

Before leaving, you must be sure your area is clean and trash-free. You will be charged a \$50 cleaning fee if your area is not clean and not free of damage.

SPACE ALLOCATION:

We will assign vendor spaces. Placement, flow and competition will be taken into consideration to provide the best experience for all attendees. Each vendor will get space for a 6' table. Tables provided upon request at no extra cost. You must provide your own electric cords if applicable and your own chairs at this time.

VENDOR RESPONSIBILITIES:

Each vendor is responsible for the conduct of their representatives and/or employees. Your activities must not detract from the image or welfare of the fair. Vendor tables must be manned at all times. Selling outside of your designated booth and/or space is not permitted. One-Eighty Consignment & Thrift Shoppe is not responsible for merchandise or display materials. One-Eighty Consignment & Thrift Shoppe is not liable for any losses or damages and makes no guarantee of attendance or sales.
